

EXECUTIVE SUMMARY

This report provides a snapshot of crime statistics pertaining to the incidents reported to York Regional Police in 2020. The report outlines select indicators based on a five-year trend. Crime rates are calculated for York Region, Districts and Municipalities using the corresponding population estimates¹ received from the Regional Municipality of York.

The World Health Organization (WHO) declared a novel coronavirus (COVID-19) outbreak a global pandemic on March 11, 2020, and on March 17, 2020, Canada and the Province of Ontario declared a state of emergency. Data presented in this report reflects the social, economic and sociological impacts of the COVID-19 pandemic on individuals and businesses in York Region.

The **911 Communications Centre** received 622,067 calls in 2020 of which 40.3% were emergency 9-1-1 calls and 59.7% were non-emergency calls. Call response time decreased in 2020 for Priority 1 (emergency) calls, Priority 2 (high priority) calls and Priority 3 (medium priority) calls compared to 2019. The response times for Priority 1 calls decreased from 6:50 minutes to 6:44 minutes or 1.5%, for Priority 2 calls decreased from 14:10 minutes to 13:24 minutes or 5.4% and for Priority 3 calls decreased from 25:39 minutes to 23:41 minutes or 7.9%, in 2020.

255,407 **Citizen Generated Calls for Service** were received in 2020 compared to 275,292 calls in 2019, a 7.2% decrease. Of these calls, 98,042 (40.4%) were dispatched, 5,395 calls (2.2%) were diverted to the Community Resource Centre and Alternate Response Unit, and 12,627 calls (5.2%) were diverted to online reporting.

36,714 **Criminal & Federal Violations** were reported in 2020, a decrease of 4,199 violations or 10.3% from 2019. The Total Crime Rate per 100,000 population decreased to 3,025.21 or by 11.1% in 2020 from 3,402.23 in 2019. The rate increased for Drug Violations (42.1%) but decreased for Crimes Against Persons (1.0%), Crimes Against Property (16.8%), Other Criminal Code (9.5%), Weapons Violations (0.2%), Other Federal Violations (62.3%) and Traffic Violations (18.8%).

8,830 **Crimes Against Persons Violations** (violent crime) were reported in 2020 compared to 8,837 violations in 2019, a decrease of 7 violations or 0.1%. The rate per 100,000 population decreased to 727.59 in 2020 from 734.86 in 2019 or by 1.0%. The Crimes Against Persons rate increased for Robbery & Other Violent violations (5.7%), but decreased for Violations Causing Death (45.0%), Attempt Capital Crime (25.2%), Sexual Violations (13.4%), Commodification of Sexual Activity (31.5%), Assault (2.7%), and Violations Deprivation Freedom (5.5%).

Robbery Violations reported in York Region decreased to 259 violations in 2020 from 366 violations in 2019, or by 29.2%. The breakdown of 2020 robberies included Street Robberies (41.7%), followed by Retail Robberies (22.0%), Financial Robberies (9.6%), Home Invasions (8.5%) and Carjackings (8.1%).

1,467 **Drug Violations** were reported in 2020 compared to 1,023 violations in 2019, an increase of 444 violations or 43.4%. The rate per 100,000 population increased to 120.88 in 2020 from 85.07 in 2019, or by 42.1%. Of the Drug Violations categories, the rate increased for Possession (39.9%), Trafficking (48.9%) and Production (8.7%).

6,131 **Intimate Domestic Related** occurrences (criminal and non-criminal) were reported in 2020 compared to 5,701 occurrences in 2019, an increase of 430 occurrences or 7.5%. Of the intimate domestic related occurrences, criminal charges were laid for 1,869 or 30.3% occurrences.

Reported **Hate Crime** occurrences in York Region increased to 160 incidents or by 20.3% in 2020 from 133 incidents in 2019. The principle motivation factors for reported hate crime were race/ethnicity (55.6%), religion (23.8%) and sexual orientation (13.8%). When race/ethnicity was the principle motivation factor, members of the Black (43.8%), East & Southeast Asian (21.3%), Arab/West Asian (13.5%), South Asian (7.9%), Aboriginal (7.9%) and Multiple Races/Ethnicities (2.2%) communities were the most frequent victims. When religion was the principle motivation factor, citizens of the Jewish (78.9%), Muslim (18.4%) and Catholic (2.6%) religions were the most frequent victims.

21,340 **Crimes Against Property Violations** (property crime) were reported in 2020 compared to 25,423 violations in 2019, a decrease of 4,083 violations or 16.1%. The rate per 100,000 population decreased to 1,758.40 in 2020 from 2,114.12 in 2019, or by 16.8%. Of the Crimes Against Property categories, the rate increased for Arson (17.3%), Theft Over \$5,000 (0.8%), and Fraud (1.4%). The rate decreased for Break and Enters (35.4%), Theft Under \$5,000 (23.9%), Have Stolen Goods (39.1%), and Mischief (2.5%).

The number of **Stolen Vehicles** in York Region increased to 1,417 in 2020 or by 2.4% from 1,384 in 2019, and the rate per 100,000 population increased by 1.5%. Honda (62), Toyota (47), Mercedes (46), BMW (34), Lexus (32), Audi (20), Volkswagen (20), Hyundai (19), Mazda (18), and Acura (16) were the top ten stolen automobiles. The top 10 stolen trucks² were Lexus (209), Toyota (99), Honda (92), Ford (89), Land Rover (43), Mercedes (40), Dodge (39), GMC (36), Chevrolet (34), and Jeep (21).

4,985 Other Criminal Code Violations (including Weapons and Public Morals) were reported in 2020 compared to 5,388 violations in 2019, a decrease of 403 or 7.5%. The rate per 100,000 population decreased to 410.76 in 2020 from 448.05 in 2019, a decrease of 8.3%.

4,069 **Criminal Traffic Violations** were reported in 2020, a decrease of 895 violations or 18.0% from 2019, and the rate per 100,000 population decreased by 18.8%. Of the Traffic Violations categories, the rate increased for Dangerous Operation (14.9%), Impaired Operation (0.9%) and Drive While Prohibited (33.5%), but decreased for Fail to Stop or Remain (34.9%).

8,790 **Motor Vehicle Collision** reports were processed in 2020, a decrease of 4,295 reports or 32.8% from 2019. The rate per 100,000 population decreased by 33.4%. There were 21 Fatal Collisions in 2020, where 23 persons were killed including 11 drivers, 7 pedestrians, 3 passengers and 2 cyclists. The major contributing factors for fatal collisions were speed (30.4%), inattention (26.1%), carelessness (13.0%), alcohol (8.7%), suicide (8.7%), medical issues (8.7%) and drugs (4.3%).

Of the **Provincial Traffic Violations**, the rates per 100,000 population decreased for Speeding (to 2,700.23 from 2,899.96 or 6.9), Red Light infractions (to 117.17 from 148.35 or 21.0%), Disobeying Stop Sign (to 977.17 from 1,132.27 or 13.7%), Seatbelt Related Violations (to 72.59 from 102.95 or 29.5%), Drive Under Suspension (to 210.78 from 227.60 or 7.4%), Careless Driving (to 288.56 from 450.05 or 35.9%), and Fail to Remain (to 8.73 from 10.15 or 13.9%).

The **Youth Crime** rate per 1,000 population decreased to 9.83 in 2020, or by 49.5% from 19.46 in 2019. The number of young persons involved in violent crimes decreased to 461 or 42.1% in 2020 from 796 in 2019, and for property crimes the number decreased to 362 or 56.5% in 2020, from 832 in 2019.

The overall **Clearance Rate**³ for Total Criminal and Federal Violations (excluding Traffic) decreased to 49.6% in 2020, from 50.5% in 2019. Clearance rates vary by crime type. The rates increased in 2020 for Other Criminal Code (to 88.7% from 86.3%) and Traffic Violations (to 54.4% from 42.6%), but decreased for Crimes Against Persons (to 60.8% from 64.7%), Crimes Against Property (to 32.8% from 35.7%), Weapons Violations (to 81.5% from 82.3%), Drug Violations (to 92.0% from 97.0%), and Other Federal Violations (to 100.0% from 104.1%).

Non-Criminal Statistics

2,072 **Mentally III Persons** reports were submitted in 2020, a decrease of 185 reports or 8.2% from 2019. In the last five years, Mentally III Persons reports increased 22.2%.

2,759 **Mentally Ill Apprehension** reports were submitted in 2020 compared to 2,826 in 2019, a decrease of 67 reports or 2.4%. In the last five years, Mentally Ill Apprehensions increased 39.1%.

139 **Suicide Attempt** reports were submitted in 2020, a decrease of 37 reports or 21.0% from 2019. In the last five years, Suicide Attempts decreased 53.8%.

1,011 **Non-Criminal Death** reports were submitted in 2020, an increase of 223 reports or 28.3% from 2019. In the last five years, Non-Criminal Deaths increased 48.2%. Non-criminal deaths include natural deaths and non-natural deaths such as suicides, non-traffic accidental deaths and deaths-undetermined⁴.

488 **Missing Adult** reports were received in 2020, a decrease of 78 reports or 13.8% from 2019. In the last five years, Missing Adult reports decreased 85 or 14.8%.

233 **Missing Young Person** reports were received in 2020, a decrease of 67 reports or 22.3% from 2019. In the last five years, Missing Youth reports decreased 148 or 38.8%.

Miscellaneous Statistics

Police Clearance Letters for employment processed by the Information Management Bureau decreased to 32,521 letters or by 42.1% in 2020, from 56,184 letters in 2019. Volunteer screenings decreased to 7,226 in 2020, or by 39.6% from 11,966 in 2019. The number of Warrants processed decreased to 1,255 in 2020, or by 37.3% from 2,000 in 2019. The number of MVC/Incident Summary Reports decreased to 2,029 in 2020, or by 17.1% from 2,449 reports in 2019.

The number of **Freedom of Information** requests received by the Legal Services Bureau decreased to 2,653 in 2020, or by 18.9% from 3,271 in 2019. The volume of formal requests decreased to 1,381 in 2020 from 1,746 in 2019, or by 20.9%, while the volume of informal requests decreased to 1,272 in 2020 from 1,525 in 2019, or by 16.6%.

The volume of **Alarm Calls** received in York Region decreased to 6,211 calls in 2020, or by 42.1% from 10,718 in 2019. The volume of false alarm calls decreased by 65.7% to 3,114 calls in 2020 from 9,079 calls in 2019. The proportion of false alarm calls decreased to 50.10% in 2020 from 85.0% in 2019.

The number of tips received by **Crime Stoppers** decreased to 3,732 or by 20.3% in 2020 from 4,682 tips in 2019. The tips resulted in 153 arrests in 2020, which is 71.9% more from the number of arrests made in 2019. The value of property recovered increased to \$35,530,826, or by 453.4% in 2020 from \$6,420,995 in 2019. The value of drugs seized increased to \$747,168, or by 215.2% in 2020 from \$237,039 in 2019. The number of weapons seized increased to 52, or by 333.3% in 2020 from 12 weapons in 2019. Rewards authorized decreased to \$2,200, or by 86.7% in 2020 from \$16,593 in 2019.

Victim Services of York Region served 14,762 clients in 2020 compared to 8,574 clients in 2019, an increase of 6,188 clients or 72.2%. The breakdown of 2020 clients included 55.9% women, 20.6% men and 23.5% children (0-15 years). The program received 16,680 telephone crisis calls/office visits in 2020 compared to 12,651 calls/visits in 2019, an increase of 31.8%. However, on-scene occurrences decreased 62.2% to 345 in 2020 from 912 in 2019. Research demonstrates that due to the COVID-19 pandemic, the need for social service support increased. Pandemic lockdowns caused families to be confined at home, school closures, and job losses, resulting in possible increased tensions in the home. For those experiencing violence, especially in the home it is difficult to access regular networks and sources of support, formally and informally, leading to an increase in telephone crisis calls.⁵

INTRODUCTION

This report documents aggregate level crime statistics pertaining to the incidents reported to York Regional Police between January 01 and December 31, 2020. The report is structured into three sections: statistics for York Region, statistics for the Districts and statistics for the Municipalities. Results of the current reporting year (2020) are compared with the previous year (2019) for all the data tables prepared for the York Region, Districts and Municipalities. Trends in the last five years (2016-2020) are provided for key indicators of regional data. A glossary of terms, types of violations and changes in Uniform Crime Reporting (UCR) survey methodology during last five-year period are included in the appendices.

METHODOLOGY

The Canadian Centre for Justice and Community Safety Statistics (CCJCSS) of Statistics Canada, in conjunction with police jurisdictions across Canada, collects *Criminal Code* violations data through the incident based Uniform Crime Reporting (UCR) survey methodology. The UCR survey was established in 1962 with cooperation and assistance to the Canadian Association of Chiefs of Police (CACP). The UCR survey was designed to measure criminal incidents that have been reported to federal, provincial/territorial and municipal police services in Canada.

UCR survey methodology classifies incidents according to the four most serious violations in the incident (generally the violations that carry the longest maximum sentences under the *Criminal Code*). Violent incidents are classified differently from other types of crime. For violent crime, a separate incident is recorded for each victim. In categorizing incidents, violent violations always take precedence over non-violent violations.

York Regional Police implements UCR survey methodology and captures data in the process of receiving incident reports, providing investigative services and resolving the incidents, where possible. York Regional Police publishes crime statistics based on the number of reported violations using the UCR survey methodology. Crime counts presented in this report are based on all violations in a criminal incident.

The Regional Municipality of York Planning Department has provided 2020 population estimates of York Region, Districts and Municipalities. The estimates are based on the results of Census 2016 counts⁶ and Canada Mortgage and Housing Corporation (CMHC) housing completion data in York Region. Crime rates are calculated based on the year-end population estimates received from the Regional Municipality of York.

The Regional Municipality of York adjusted its population estimates of 2016-2018 lower based on the Census 2016 results published in 2018 by Statistics Canada.







The report includes statistics for the Alarm Program, Crime Stoppers, Legal Services, Victim Services of York Region and other services (police clearance letters, volunteer screening, MVC/Incident summary reports, warrants processed etc.) provided by the Information Management Bureau. Also, the report includes information for selected non-criminal statistics such as mentally ill persons, mental health apprehensions, suicide attempts, non-criminal deaths and missing persons.

Crime rates incorporated in this report were estimated for all categories irrespective of the size of the denominator. Generally, rates and ratios are not reliable if it is based on a small number (less than 30). Readers are requested to consider the fact of 'small number' while using crime rate data presented in this report.

For a reported incident, York Regional Police provides investigative resources towards resolving an incident. For some crime types, the process may take years as new investigative information is updated in the records management system. All data in this report is based on reported crime and represents a "snapshot" at the time of extraction from the records management system at year-end. Unless otherwise noted, any updates or revisions to data for the years prior to 2020 are not reflected in this report.

MAKING COMPARISONS

Unless otherwise noted, all crime statistics in this report are compiled using the "all violations" methodology. The statistics presented in this report should not be compared with those provided by the Canadian Centre for Justice and Community Safety Statistics (CCJCSS), a division of Statistics Canada. The CCJCSS published data measures only the most serious offence related to an incident. In addition, the CCJCSS includes the number of offences reported by the Toronto North Detachment of the Royal Canadian Mounted Police (RCMP) with York Regional Police's crime statistics.

However, the CCJCSS data should be used for comparisons between policing jurisdictions, municipalities and provinces as all data is compiled using the same reporting methodology and those include incidents reported to municipal, provincial and federal policing organizations.

Crime statistics of 2020 were impacted by the COVID-19 pandemic restrictions imposed by the Regional Municipality of York, the Province of Ontario and Canada on March 17, 2020. The 2020 data presented in this report demonstrates the impact of the pandemic and how it affected crime statistics on individuals and businesses.






- 8,830 Crimes Against Persons violations were reported in 2020 compared to 8,837 during the corresponding period in 2019. This represents a decrease of 7 violations or 0.1%.
- The Violent Crime rate in 2020 was 727.59 per 100,000 population compared to 734.86 during the corresponding period in 2019, a decrease of 1.0%.

APPENDIX A: GLOSSARY OF TERMS

Actual totals include only those incidents for which an occurrence report was made and have been substantiated through police investigation.

ATM Robberies include robberies at ATM machines within financial institutions or at stand-alone locations where the victim is approached and forced to withdraw money or is robbed as they are leaving the machine.

Calls to 9-1-1 Communications Centre include all telephone calls, 911 and non-emergency, made by members of the public.

Car Jacking includes robberies where the intent is to steal a motor vehicle with the use or threat of violence against the person(s) in care or control of that vehicle.

Charged/Suspect-Chargeable (CSC) is a person who has been identified as an accused in an incident and against whom a charge may be laid in connection with the incident.

Citizen Generated Calls for Service occur when a citizen requests or requires a police response of any kind. Requests are received by, but not limited to, 911 telephone calls, non-emergency telephone calls, walk-in requests, online reports, or requests via other agencies.

Clearance Rates are calculated by the number of violations cleared by charge or otherwise (persons processed by other means) divided by the number of violations. These violations may not necessarily have occurred during the reporting period but sometime prior.

Complainant is the target of a non-violent incident. The complainant can be a person or a company depending on the type of crime.

Crime Rates are expressed as a rate per 100,000 population using year-end population estimates supplied by the York Region Long Range Planning Department and have been rounded to two decimal points. The rate for youth crime is based on 1,000 youth population.

Deposit Robberies include robberies where a business deposit is stolen from a person using force.

Dispatched Calls are those 911 emergency telephone calls and non-emergency telephone calls, which are received at the communications bureau, assessed and then dispatched to front-line officers to assist victim(s) or address concerns.

Fatal Motor Vehicle Collisions Contributing Factors are based on the Major Collision Investigation Unit's interpretation of each collision. Distracted driving is counted if there is some physical or witnessed evidence to suggest the collision was linked to distraction. Inattentive is based on witness or physical evidence that would cause belief that the responsible driver was inattentive and there is no other explanation for the collision. All other categories are self-explanatory.

Financial Robberies include robberies occurring at banks, credit unions, or involving armoured cars.







APPENDIX A: GLOSSARY OF TERMS (CONT'D...)

Hate Crime means a criminal offence committed against a person or property, which is motivated by the offender's bias, prejudice, or hate based on victim's race, national or ethnic origin, language, colour, religion, sex, age, mental or physical disability, sexual orientation, or any other similar factor.

Home Invasion is an intrusion into a residence with the intent of robbing the occupants therein.

Incident or criminal incident is the set of connected events that usually constitute in a police occurrence report. An incident may involve several victims, several CSCs, and multiple violations of the law. An incident report in RMS can contain up to four different violations.

Non-Criminal Deaths include natural deaths, suicidal deaths, non-traffic accidental deaths and undetermined deaths. The last three categories constitute non-natural deaths.

Offence is defined as a statistical fact for aggregate-based reporting. This terminology is not used in incident-based reporting.

Other Robberies include robberies that do not meet the criteria for any of the other categories. Examples include hotel robberies, robberies by uninvited guests at house parties, and break and enter occurrences that result in a robbery occurring.

Retail Robberies include robberies occurring at retail or commercial premises including convenience stores, restaurants/fast food establishments, massage parlours, gas stations, and donut/coffee shops.

Street Robberies include muggings, intimidation style robberies, and all other robberies by force or threat of force that occurs in a public place.

Unfounded incidents are those where it has been determined through police investigation that the offence reported did not occur, nor it was attempted. This new definition of unfounded was introduced in January 2018. The prior definition of unfounded was 'an incident is unfounded if it has been determined through police investigation that no violations of law took place at that time or location'.

Founded incident is if, after police investigation it has been determined that the reported offence did occur or was attempted or there is no credible evidence to confirm that the reported incident did not take place. This includes third party reports that fit these criteria.

Violation refers to a contravention of the *Criminal Code, Federal,* or *Provincial Statutes*.

Victim is a person who is the target of a violent or aggressive action or threat.

Young Person or Youth refers to a person aged 12 - 17 years inclusive (Youth Criminal Justice Act).

Youth Crime Rate refers to the number of youths formally charged plus processed by other means for committing a criminal or federal offence per 1,000 youth population. Youth population (12-17 inclusive) estimates used are supplied by the York Region Long Range Planning Department.

APPENDIX B: TYPE OF VIOLATIONS

Crimes Against Persons are crimes involving aggressive action (with the intent to do harm) or threat of such action by one person against another. These include violations causing death, attempt capital crime, sexual violations, commodification of sexual activity, assault, robbery and other violent violations, and violations/deprivation of freedom.

Violations Causing Death include murder 1st degree, murder 2nd degree, manslaughter, infanticide, criminal negligence cause death, and other related offences causing death.

Attempt Capital Crime violations include attempted murder and conspiracy to commit murder.

Sexual violations include aggravated sexual assault, sexual assault with a weapon or cause bodily harm, and level 1 sexual assault. This category also includes sexual violations that specifically apply to children such as invitation to sexual touching, sexual exploitation, incest, corrupting morals of a child, making sexual explicit materials available to children, voyeurism, bestiality, luring child via computer, anal intercourse, householder permit sexual activity, and distribution of intimate images.

Commodification of Sexual Activity violations include obtaining sexual services, material benefit from sexual services, procuring and advertising sexual services.

Assault violations include aggravated assault, assault with a weapon or cause bodily harm, level 1 assault, unlawfully cause bodily harm, discharge firearm with intent, assault peace/public officer, criminal negligence cause bodily harm, use firearm/imitation in commission of offence and point firearm.

Robbery and Other Violent violations include robbery, extortion, criminal harassment, uttering threats, explosives causing death/bodily harm, arson disregard for human life, intimidation of a justice system participant, intimidation of a non-justice system participant, indecent/harassing communications, forging/destruction of documents associated with Medical Assistance in Dying (MAID) and failure to comply with safeguards (MAID).

Violations/Deprivation of Freedom include kidnapping, forcible confinement, hostage taking, trafficking in persons, removing child from Canada, and abduction.

Crimes Against Property involve unlawful acts with respect to property but do not involve the use or threat of violence against an individual. These include arson, break and enter, theft, possession/trafficking of stolen goods, fraud, and mischief.

Drug violations include violations under the *Controlled Drugs and Substances Act* and the *Food and Drug Act*. These violations are comprised of possession, trafficking, and importation/exportation or production of various illicit controlled drugs and substances.

Weapons violations include violations under the *Criminal Code*, which involve any thing used, designed to be used or intended for use in causing death or injury to any person or used for the purpose of threatening or intimidating any person. These include possession, use, trafficking, pointing, unauthorized import/export, firearms documentation and administration, and unsafe storage.







APPENDIX B: TYPE OF VIOLATIONS (CONT'D...)

Prostitution/Public Morals violations include prostitution/public morals and gaming and betting. The definition of public morals violation was revised in 2016.

Other Criminal Code violations include the remaining non-traffic *Criminal Code* violations that are classified as neither violent nor property violations. These violations are divided into two parts:

Part A: includes bail violations, counterfeiting currency, disturb the peace, escape custody, indecent Act, child pornography, public morals, obstruct peace/public officer, prisoner unlawfully at large, trespass at night, fail to appear, breach of probation, utter threats to property-animal, advocating genocides, and public incitement of hatred.

Part B: includes unauthorized recording of movie, offences against public order, offences relating to terrorist activity, offences against administration of law and justice, invasion of privacy, offences against the person and reputation, offences against the rights or property, fraudulent transactions/contracts and trade, intimidation of justice system participant, willful/forbidden acts/respect of certain property, offences related to currency, proceeds of crime, attempts/conspiracies/accessories, offences relating to criminal organization, and all other *Criminal Code* violations.

Federal Statutes violations include violations under all other federal statutes. They include the Bankruptcy Act, Income Tax Act, Canada Shipping Act, Canada Health Act, Customs Act, Competition Act, Excise Act, Immigration/Refugee Protection Act, Firearms Act, National Defense Act, Young Offenders Act, Youth Criminal Justice Act, and Other Federal Statutes.

Traffic violations include all traffic violations under the *Criminal Code*. These include dangerous operation, evade police, impaired related violations (alcohol and drug), street racing, and other criminal traffic violations including fail to stop or remain and drive while prohibited.

Hate Crime means a criminal offence committed against a person or property, which is motivated by the offender's bias, prejudice, or hate based on race, national or ethnic origin, language, colour, religion, sex, age, mental or physical disability, sexual orientation, or any other similar factor.

Homicide includes first and second degree murders, manslaughter and infanticide. Deaths caused by criminal negligence, suicide and accidental or justifiable homicide are not included in this classification.

Cybercrime is defined as a criminal offence involving computer or such device as the object of the crime or the tool used to commit a material component of the offence. Texting, messages on Facebook, Twitter and other such social media are considered as cyber-crime activity if a criminal offence is involved.

Organized Crime is a criminal offence committed by members of a criminal organization or street gang for material benefits or financial gains or in order to obtain power and recognition and/or control specific areas of criminal activities.







APPENDIX C: CHANGES IN UCR SURVEY REPORTING METHODOLOGY

(2016-2020)

Changes are made to UCR survey methodology by the Canadian Centre for Justice and Community Safety Statistics (CCJCSS) of Statistics Canada. There are two types of changes that affect UCR survey: changes brought in by the Government of Canada in the form of a new bill or law, and changes that are initiated by the CCJCSS, most often because of feedback or requests from police services or recommendations from the Canadian Association of Chiefs of Police (CACP). This section also includes policy and operational changes made by York Regional Police that might affect crime statistics presented for the municipalities, Districts or for the Region. The following sections outline what changes were made to the UCR survey methodology during the last five-year period, 2016-2020.

In 2016, changes were made to UCR methodology in relation to Bill C-36 the Protection of Communities and Exploited Persons Act, which was granted royal assent in December 2014. The legislation resulted in updates to: a) sexual offences against children, b) commodification of sexual activity, c) offences in relation to offering, providing or obtaining sexual services for consideration, and, d) disorderly houses, gaming and betting offences. New violations classified as 'commodification of sexual activity' under Crimes Against Persons included purchasing sexual services, receiving material benefit from the purchase of sexual services and advertising sexual services. The changes were implemented in May 2016.

In May 2016, the Bill C-14 *Medical Assistance in Dying Act, 2016* was granted royal assent resulting in the addition of three new UCR Survey violations codes for failure to comply with safeguards/regulations and forging/destruction of documents. The new offences were incorporated in 2016.

In May 2017, Bill C-37 An Act to amend the Controlled Drugs and Substances Act and to make related amendments to other Acts was granted royal assent, resulting in increased penalties for six drug violations. CCJCSS adjusted the UCR Survey and the changes were implemented in 2017.

In November 2017, the Canadian Centre for Justice and Community Safety Statistics (CCJCSS) added four new violation codes specific to opioids (other than heroin) to the Uniform Crime Reporting (UCR) survey. The addition of these codes was in response to the need expressed by police services to capture the prevalence of opioids using violation codes specific to these types of drugs. Previously, offences related to the possession, trafficking, importation and exportation and production of opioids (other than heroin) were included under 'other controlled drugs and substances'. The changes were implemented in December 2017.

In December 2017, Bill C-305 An Act to amend the Criminal Code (mischief) was granted royal assent, resulting in changes of the definition of violation code 2176 to 'Hate motivated mischief relating to property used by identifiable group' from 'Mischief to religious property motivated by hate'. The enactment amended Section 430(4.1) of the Criminal Code. CCJCSS made changes to UCR Survey and the changes were implemented in 2018.







APPENDIX C: CHANGES IN REPORTING METHODOLOGY (CONT'D...)

In January 2018, the Canadian Centre for Justice and Community Safety Statistics in consultation with the Police Information and Statistics (POLIS) Committee made UCR methodology changes by introducing new standards for reporting founded and unfounded incidents. The definitions of both unfounded and founded were updated as:

<u>Unfounded</u>: An incident is unfounded if it has been determined through police investigation that the offence reported did not occur, nor it was attempted.

<u>Founded</u>: An incident is founded if, after police investigation it has been determined that the reported offence did occur or was attempted or there is no credible evidence to confirm that the reported incident did not take place. This includes third party reports that fit these criteria.

In June 2018, the Canadian Government granted royal assent to Bill C-45: "An Act respecting cannabis and to amend the Controlled Drugs and Substances Act, the *Criminal Code* and other Acts". The come into force date for the legislation was October 17, 2018. In response to the legislation, CCJCSS has introduced 22 new drug offences to the Uniform Crime Reporting (UCR) Survey. The existing four cannabis-specific violations were expired. The changes were implemented in 2018.

In June 2018, the Canadian Government granted royal assent to Bill C-46: 'An Act to amend the Criminal Code (offences relating to conveyances) and to make consequential amendments to other Acts'. In response to the legislation, CCJCSS made changes to the UCR methodology in two steps (part). The come into force date for part 1 of the legislation was June 21, 2018, and for part 2 was December 18, 2018. The changes were implemented in December 2018.

Part 1 of Bill C-46 amended the provisions of the *Criminal Code* that deal with offences and procedures relating to impaired driving. As a result, seven new UCR violation codes were added to the survey. Of those, one violation captures operation while impaired with a low blood drug concentration, three violations capture impaired driving where the substance (whether alcohol or drug) causing impairment is not known, and three violations capture impaired driving where it is known that the impairment was caused by a combination of alcohol and drugs.

Part 2 of Bill C-46 repealed the provisions of the *Criminal Code* that deal with offences and procedures relating to conveyances, including those provisions enacted by part 1, and replaced them with provisions in a new part of the *Criminal Code*. In response to part 2 of Bill C-46, all existing UCR traffic violation codes were mapped to new *Criminal Code* sections or expired. Altogether, 12 new violations were added, 15 violations (including three provincial offences) were expired and the maximum penalties were increased for 15 pre-existing offences.

In December 2014, The Canadian Government granted royal assent to Bill C-13 'Protecting Canadians from Online Crime Act.' The legislation raised the maximum penalty for Criminal Code section 372. The come into force date was December 9, 2014, but the change was not implemented in the UCR survey by CCJCSS at that time. Effective October 2018, the maximum penalty 'indecent/harassing communications' was increased from six months to two years. The related changes were implemented by CCJCSS in 2018.

APPENDIX C: CHANGES IN REPORTING METHODOLOGY (CONT'D...)

In December 2018, CCJCSS in consultation with the Police Information and Statistics Committee, introduced a number of changes to the gender category in the Uniform Crime Reporting Survey. The changes were in response to Bill C-16: An Act to amend the Canadian Human Rights Act and the Criminal Code which came into force on June 19, 2017. This legislation added gender identity and gender expression to the list of prohibited grounds of discrimination and protects members of the public who are distinguished by gender identity or expression against offences motivated by bias, prejudice, or hate. The changes were implemented in December 2018.

In June 2019, the Canadian Government granted royal assent to Bill C-75, "An Act to amend the Criminal Code, the Youth Criminal Justice Act and Other Acts to make consequential amendments to other Acts". As a response to the legislation change, CCJCSS made changes to the UCR survey methodology by expiring two offences and increasing maximum penalties for nine existing offences. York Regional Police implemented the associated changes in July 2019.

In November 2019, CCJCSS introduced the new violation of 'sexual offence occurring prior to January 04, 1983' to the UCR survey for capturing historical sexual offences. The change was implemented in December 2019.

On March 17, 2020, the Province of Ontario made a declaration under the *Emergency Management and Civil Protection Act (EMCPA)*. In a letter to all Chiefs of Police, the Ontario Ministry of the Solicitor General informed Police Services about new set fines for offences under the EMCPA. York Regional Police implemented these provisions immediately.

In April 2020, the Canadian Centre for Justice and Community Safety Statistics (CCJCSS) made adjustments to the Uniform Crime Reporting Survey in response to the Federal Government amendments to the *Contraventions Regulations (Quarantine Act)*. New offence codes were introduced for federal violations of the *Quarantine Act* and implemented at York Regional Police immediately.

In April 2020, the City of Vaughan introduced a by-law to regulate activities deemed to have a potentially adverse impact on the health and wellbeing of the public during the COVID-19 Emergency. The by-law was in line with the declaration of Emergency by the Province of Ontario. New offence codes were introduced in April 2020 as per the by-law.

In July 2020, the Canadian Centre for Justice and Community Safety Statistics (CCJCSS) introduced changes to selected prostitution violation labels used for collection and publication within the Uniform Crime Reporting Survey. The new labels were endorsed by the Police Information and Statistics (POLIS) Committee in September 2019. The changes were implemented within York Regional Police immediately.
